K Jain**, 1364 II floor, 4th cross I stage II phase, Chandra layout, Bangalore 560040 hereinafter called **THE SETTLOR**, which expression shall, unless inconsistent with or repugnant to the subject or context, include her heirs, executors, administrators, assigns and representatives of the ONE PART; and

Ms. Meena. K Jain D/o late H. Sohanmal Jain aged about 45 years, and residing at present at 1364 II floor I stage II phase Chandra layout, Bangalore-40, hereinafter called "**FOUNDER TRUSTEE**", which expression shall, unless inconsistent with or repugnant to the subject or context, include the Trustee or Trustees for the time being of these presents, survivor or survivors of any of them, and their successor or successors in office and their executors and administrators, of the OTHER PART.

WHEREAS the Settlor, is desirous of constituting a public charitable trust without any intention to make any profit, for Public Charitable purposes with the aim of powerfully transforming the quality of life of terminally ill, developmentally challenged and underprivileged persons especially children and adolescents and any other children in distress.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

1. TRANSFER OF PROPERTY:

The Settlor of the trust hereby conveys, transfers, grants and delivers out of the funds belonging to her a sum of Rs.1,000/- (Rupees One Thousand Only) by way of trust and entrust the same to the Trustees to have and hold the same on trust as the initial corpus fund for the purpose hereinafter mentioned. There is no other immovable property attached to this Trust.

2. NAME OF THE TRUST:

The name of the Trust shall be "**SAMBHAV FOUNDATION**" hereinafter referred to as "The Trust".

The Objectives of the Trust shall be:




- (g) To institute studentships, scholarships, stipends, medals, prizes, etc. and to help and encourage deserving students and to provide monetary aid to students, scholars and teachers for pursuing their education.
- (h) To organise, establish and assist in providing placement to the terminally ill, developmentally challenged and underprivileged persons and other weaker sections of the society.
- (i) To establish, maintain, run, develop, improve, extend and to donate for and to aid in the establishment, maintenance, running, development, improvement and extension of children's home, crèches, orphanages, home for the aged, rescue home, rehabilitation centers and similar institutions.
- (j) To organise, run and assist in organising and running counseling centers, guidance cells, drug de-addiction centers and the like.
- (k) To establish, maintain, run, develop, improve, extend and to donate for and to aid in the establishment, maintenance, running, development, improvement and extension of hospitals, clinics, dispensaries, medical laboratories, research units and similar institutions affording treatment, cure, rest, recuperation and medical relief to the public.
- (l) To give food, clothing and cash grants to the terminally ill, developmentally challenged underprivileged children and the poor and the needy.
- (m) To educate, train and motivate people to be of help and assistance to the terminally ill, developmentally challenged, underprivileged children poor and needy.

4. TRUSTEES:

- 4.1 The following person shall constitute the trustee

- 4.2 The Trustee shall be entitled to delegate such powers and duties as they think fit and proper.
- 4.3 A Trustee may resign his/her office as Trustee by giving notice in writing to his Co-trustees as and when inducted.
- 4.4 If the Trustees hereby constituted or any of them or Trustees/Trustee appointed as provided in this Deed shall die or discharge or refuse or become unfit or incapable to act, then and in every such case, such Trustees/Trustee shall be deemed to have vacated his office.

5. TRUST PROPERTY:

The term "Trust Property" shall mean the whole or any part of the aforesaid moveable property, all additions and accretions thereto, the income thereof, the acquisitions therewith, the rights and privileges acquired, the conversion thereto in any other form, and all other property which may from time to time vest in, or come from any source to the Trust.

6. POWERS, RIGHTS, DUTIES AND RESPONSIBILITIES OF THE TRUSTEES:

The Trustees shall stand and be possessed of the Trust and all additions to the Trust Fund and all income arising there from upon the Trust and subject to their powers, rights, duties and responsibilities herein below declared concerning the same.

6.1 The Trustees shall be entitled to receive the annual or other income of the Trust of these presents themselves and to pay and discharge all the costs and expenses incurred in or about the administration of the Trust of these presents.

6.2 The Trustees shall be entitled to spend, hand over, apply or allocate the annual or other income of the Trust for the objects, hereinabove mentioned in any proportion the Trustees may deem fit at their discretion.

6.3 When the Trustees decide not to spend, hand over, apply or allocate any income but to accumulate the same, the same will be accumulated for the objects hereinabove mentioned to be spent, handed over, applied or allocated at any later date.

6.4 For carrying out the objects, the Trustees may engage in and carry on business or businesses for and on account of the Trust established by this Deed and may invest any part of the fund or assets of the Trust. In the course of such business the Trustee may do all that necessary for carrying on such business or businesses. They may sign contracts, open Bank Accounts, sign Cheques, negotiate documents, institute legal proceedings, and do all that is necessary for the successful carrying on of the business or businesses and execution of the Trust.

6.5 The Trustees shall have the authority to deposit the securities or investments of the Trust with the Bankers for safe custody and collection of interest, dividend, etc. and also to deposit the Trust Fund in the Bank Account opened in the name of the Trust and operated jointly by any two of the Trustees.

6.6 The Trustees shall invest such surplus funds of the Trust that require investment only in the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income tax Act, 1961 or such modes as may be prescribed by any subsequent alteration, amendment or addition to the said Act dealing with investment of Trust Fund.

6.7 The Trustees are hereby expressly authorised to accept gifts or money or moveable or immovable property from any persons on such terms and conditions as may be deemed fit and proper in their discretion for the augmentation of the Trust Fund.

6.8 Without prejudice to the foregoing, the Trustees shall have power to do the following:

- To employ clerks and other employees, brokers, bankers, lawyers, accountants and others at such remuneration as they think fit;
- To delegate any power to one or more Trustees;
- To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they think fit and proper for the purpose;
- To withdraw any power or to revoke any appointment of any employee or attorney;
- To sell any or portion of any property forming part of the Trust Fund at such prices and on such terms and conditions as they think fit and proper
- To let or lease any portion of any immovable property forming part of the Trust at such rent or compensation for such periods and on such terms and conditions they may think fit and proper to accept surrender of any lease, and to file suits in ejectment and/or for recovery of rents and other dues.
- To maintain Bank Accounts in the name of the Trust;
- To appoint a proxy for voting at any of the meeting of the creditors, Share holders and /or others.

6.9 Any Trustees who being a professional or any firm in which he or she is a partner, is engaged or employed in any professional capacity to act for his Trust or do any work for this Trust may be remunerated out of the Trust fund by the Trustees for such professional work and he or she or such firm shall be entitled to charge this Trust for any professional services rendered to it by such Trustees or by such firm.

- 6.10 The funds and the income of the Trust shall be solely utilised for achieving the objects of the Trust and no portion of it shall be utilised for the benefit of the trustees by way of interest, bonus, dividend, profit, etc.
- 6.11 It shall be lawful for the Trustees for the time being of these presents to reimburse themselves, himself or herself or pay and discharge out of the Trust properties all costs, charges and expenses incurred in carrying out of these presents or in or about the execution of the Trust or powers of these presents.
- 6.12 The acknowledgment by the Trustees for the purchase moneys of any property hereby authorised to be sold or for any other moneys paid or for any shares, stocks, funds or securities transferred to them shall effectively discharge the person or persons paying or transferring the same, therefore and from being bound to see the application or being answerable for the loss or misappropriation thereof, if any.
- 6.13 The Trustees shall be respectively chargeable only for such moneys or securities or other properties as they shall actually receive not withstanding their signing any receipt for the sake of conformity and shall be answerable and be accountable only for their own acts, receipts, neglects or defaults and not for others or any bankers or of other person with whom or into whose hands any Trust moneys or funds or securities may be deposited or come, nor for the same unless the same shall happen through their own willful default respectively.
- 6.14 The Trustees decisions as to whether any sum, assets or shares or security received in respect of and forming part of the Trust Fund should be treated as capital or revenue income shall be final.
- 6.15 The Trustees shall ensure the accounts of the Trust to be maintained regularly. The accounts of the Trust for the time shall be made from the date of formation of the Trust up to 31st March following the dates for the said Information, Thereafter the accounts

- 6.23 It shall be lawful for the Trustees to resolve or decide by circular and such resolution or decision shall be as effective as resolution passed at a meeting of the Trustees.
- 6.24 The Trustees shall have power to regulate their proceedings, and if necessary to frame Rules and Regulations for any purpose and or in connection with the meeting and from time to time, to repeal, mend, add to or alter the same.
- 6.25 The Trustees shall be entitled to amend, alter and rescind any clauses of this Trust Deed to remove any difficulty that may arise for the proper conduct of its activities and to bring about any improvement, to achieve the aims and objects of the trust. However no such amendment shall be made while it may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80-G of the Income-tax Act, 1961. Further no such amendment shall be carried out without the prior approval of the Commissioner of Income tax.

DISSOLUTION:

The Trustees may dissolve the Trust by a unanimous decision in writing after transferring the assets of the Trust to any one or more person or persons or body or bodies, provided the Trustees ensure that the assets so transferred shall be used only for the objects of the Trust of these presents. In case the Trust enjoys recognition under Section 12A and under section 80G of the Income Tax Act, 1961, and in the event of dissolution, the assets remaining as on the date of dissolution shall be transferred to any body or bodies which enjoy recognition under section 12A and section 80G of the Income Tax Act, 1961.

- 7.3 Any casual vacancy arising in the Managing trustee will be duly filled. However, the vacancy need not be filled as long as there are not less than 3 members in the Managing Committee.
- 7.4 The Managing committee shall meet as often as may be required but not less than four times each year. All decisions shall be recorded in a Minutes Book.
- 7.5 Two third of the total number of members of the Managing Committee shall form the quorum of the Committee.
- 7.6 The management and supervision of the Trust shall vest in the Managing Committee. They will act as the representatives of the General Body of the Trust and act in accordance with the rules and regulations as laid down here and in good faith for the fulfillment of the objectives of the Trust.
- 7.7 The Managing Committee shall when necessary propose amendment, alteration or rescission of any rules, not inconsistent with the objects of the Trust and the same shall be placed before the meeting of the Trustees. The change shall come into effect if passed by a 2/3rd majority of voting members present.
- 7.8 The chairperson shall preside over the meetings of the Managing Committee. In her absence any member delegated by the chairperson to preside shall be the chair of the meeting. The person so presiding shall have a casting vote in addition to his own.
- 7.9 A minimum of 1 week notice shall be given to all managing committee members for convening a management committee meeting.
- 7.10 The term of office of the management committee will be for a period of two year. However, the members of the Managing Committee are eligible to stand for re-election at the end of their term.

Every dispute or differences regarding the interpretation of any of the clauses or provisions or the contents of this Deed, shall be referred to arbitration of one or more arbitrators as may be appointed by the Trustees and such disputes or differences shall be resolved in pursuance of the provisions of Indian Arbitration Act, 1940, or any other statutes in force in its place and the decision of the arbitrator or arbitrators as the case may be, shall be final and binding on the parties to such arbitration.

The settlement made upon Trust hereby created shall be irrevocable and it is hereby declared further that the value of the property at present is Rs.1, 000/-.
